

**SPLENDOR FARMS of BUSH LOUISIANA  
BOARDING AGREEMENT**

In consideration of the right to board a horse or horses at Splendor Farms and/or to use the facilities of Splendor Farms, and/or the equipment of Splendor Farms, all in accordance with the schedule of fees established by Splendor Farms from time to time, I (we) hereby agree to the following acknowledgment of risk and release of liability. For purposes of the Agreement, the words "I", "my", and "me" will include any minor of which I am the parent or legal guardian, including myself as an alone person included in this Agreement:

I acknowledge that riding, handling, and/or otherwise being in the same area of horses, whether I am mounted on the horse or working on the grounds with the horse(s) or around the horse(s), are inherently dangerous activities and may result in damage to my property and may cause me to incur serious personal injury and/or death.

I acknowledge that I am responsible for providing and wearing my own protective head gear and any other gear which may protect my body in any definition, and that if I choose not to do so, it is at my own risk and that the person(s) which I bring to Splendor Farms, or who choose to visit me while I am at Splendor Farms, either in my company or employ or in my personal or professional life and duties, it is at my own risk and the own risk of my friends, employees, and family members and that Splendor Farms is not responsible in any way, shape, or form, for anyone acquainted with me in any way while on the property of Splendor Farms or around any livestock owned or operated by Splendor Farms.

I acknowledge that Splendor Farms does not provide supervision for boarders, and that Splendor Farms advises against riding alone (and in the case of minors, against riding without appropriate supervision and when weather conditions are unsuitable for riding such as during thunderstorms, after heavy rains, or when it is excessively hot. I acknowledge that it is my responsibility to determine when weather conditions are suitable for riding. On behalf of myself, and any minor of which I am the parent of legal guardian, I hereby release and discharge, Splendor Farms and its owners, agents, employees, officers and directors, and Kelly Denise Bensabat and Albert A. Bensabat, III, personally from all liability arising out of any damage I may sustain to my person or property, including physical injury, emotional injury and/or death, or that may be sustained by any minor of which I am the parent or legal guardian, as a result of my activities (or the activities of such minor) in connection with the renting, boarding, riding or schooling of, or any other activities related to horses at Splendor Farms, and I agree not to bring any claim, demand, action or suit against any of the above-named persons or entities for any losses due to bodily injury, death, or property damage sustained by me or any minor of which I am the parent or legal guardians a result of such activities.
